# WHAT YOUR GROUP GETS

## **SKI PASS**

Fees cover lift passes.

## **EQUIPMENT**

Each group member will be fitted and provided with ski/snowboard, boots and helmets. We do not provide gloves, goggles, or the ski pants, coats, socks. Please ensure each group member is dressed appropriately.

## **LUNCH**

Please bring your own lunch, or parents can send their child with money to order menu items at the Lodge.

## **INSTRUCTORS**

Our team of instructors are skilled and trained to help your students hone their skills. From beginner to expert, each skier/snowboarder will continue to learn and grow through this program.

## **SUPERVISION**

Students will be under the supervision of school staff until they start their ski/snowboard group lessons. Once lessons start, students will be under the supervision of the Mountain Sports Instructors. After the lesson, they will return to the school staff for the remainder of their time at Sleeping Giant. Please note, school staff is responsible for gathering students at the end of the day and making sure their belongings are gathered as well.







# WHAT YOUR GROUP GETS

## WHO

Student Ski Program welcomes elementary through high school students. If there are any students that have special needs, or require extra accommodations please let us know ahead of time.

## WHAT

A group lesson, rental package, and full day lift ticket are included and priced at \$65. Groups will get one chaperone lift ticket with rentals for every 10 paid students. The lodge will be home base for students, and the upstairs will be reserved for school groups. A wall tent will be set up outside of the lodge for school groups to meet in.

## WHEN

Our group days are on Fridays. Student lessons start at 10:00 a.m., so we encourage the groups to arrive no later than 9:00 to ensure plenty of time to get their rental gear and get situated.

# WHAT YOUR STUDENT GETS

## WHERE

We ask that a designated chaperone be the one to go to the front desk in the main lodge and get lift tickets and make payment. Rental equipment will be outside the lodge and boots will be inside the lodge on the stairs. The groups will have use of a walled tent as their "home base" for the day - this is where they will bundle up and get their gear on.

## HOW

Payment can be made on the day of the trip or you can be invoiced for the bill. Groups are responsible for transportation and supervising their students when they are not in the lesson.

# WHAT TO EXPECT



## FIRST

Students will arrive at Sleeping Giant via school provided transportation.



## SECOND

Students will be brought to the lodge, and that will be their home base during their time at the mountain.



## THIRD

Students will be fitted in the rental shop for their gear.



## FOURTH

Once out on the hill, the students will be divided by skill/age and work with instructors. The lesson will last 1.5 hours.



## LAST

When lessons are complete, students and chaperones have free time to practice new skills.

## FEEES

The cost per student is \$65

## SUPERVISION

All chaperones are

## WAIVER AND RELEASE

THE ABOVE INDIVIDUAL WILL BE PARTICIPATING IN THE SLEEPING GIANT SKI PROGRAM AND ACKNOWLEDGES AND AGREES THE FOLLOWING SHALL APPLY TO THEIR PARTICIPATION IN THE PROGRAM, THE USE OF THE SLEEPING GIANT SKI AREA, AND THEIR USE OF OTHER FACILITIES TO WHICH THE PROGRAM WILL HAVE ACCESS TO.

1. THIS PROGRAM IS OPEN TO PARTICIPANTS BETWEEN THE AGES OF SIX AND EIGHTEEN YEARS OF AGE. PARTICIPANT WILL BE IN THE PROGRAM THAT IS APPROPRIATE GIVEN THEIR SKILL LEVEL AT THE TIME THE PROGRAM BEGINS. THERE ARE VARIOUS PROGRAMS OFFERED FROM TIME TO TIME FROM BEGINNING THROUGH ADVANCED SKILL LEVELS. IF THE PARTICIPANT BELIEVES HE OR SHE IS IN THE WRONG PROGRAM GIVEN THEIR SKILL LEVEL THE PARTICIPANT SHALL NOTIFY SLEEPING GIANT AND REQUEST TO BE MOVED TO A DIFFERENT PROGRAM. SLEEPING GIANT MAY REFUSE ENTRY IN A PROGRAM IN ITS SOLE DISCRETION IF THE PARTICIPANT'S SKILL LEVELS ARE NOT SUFFICIENT.

2. ALL TICKETS ISSUED TO THE PARTICIPANT ARE LIMITED TO THE PARTICIPANT ONLY AND ARE NON-TRANSFERABLE. TICKETS ARE NON-REFUNDABLE AND ARE VALID FOR THE DATE OF THE PROGRAM'S ACTIVITY ONLY, UNLESS OTHER ARRANGEMENTS HAVE BEEN MADE IN ADVANCE. ALL SALES ARE FINAL. ANY ATTEMPT TO TRANSFER OR RESELL A TICKET WILL AUTOMATICALLY VOID THE TICKET.

3. PARTICIPANT IS HEREBY NOTIFIED OF THE INHERENT RISKS RELATED TO THE USE OF THE SLEEPING GIANT SKI AREA (THE "AREA") AND THE AREA FACILITIES TO WHICH THEIR TICKET PROVIDES ACCESS. BY USING THE AREA AND FACILITIES AND PARTICIPATING IN THE ACTIVITIES AVAILABLE THE PARTICIPANT ASSUMES ALL RISKS OF ANY TYPE OR NATURE, WHETHER KNOWN OR UNKNOWN, THAT ARE ASSOCIATED THEREWITH AND IRREVOCABLY AND UNCONDITIONALLY RELEASES THE SLEEPING GIANT SKI AREA FROM ANY CLAIMS OR CAUSES OF ACTION RELATED THERETO.

4. PARTICIPANT ACKNOWLEDGES THAT UNDER WYOMING LAW A SKIER ASSUMES THE INHERENT RISKS OF SKIING AND THE UNDERSIGNED MAY BE LEGALLY RESPONSIBLE FOR DAMAGE, INJURY OR DEATH TO PERSONS OR PROPERTY THAT RESULT FROM THE INHERENT RISKS OF SKIING.

5. PARTICIPATION IN ANY WINTER RECREATION ACTIVITIES IN THE AREA INCLUDING BUT NOT LIMITED TO SKIING, SNOWBOARDING, SIGHTSEEING, CLIMBING, USE OF SKI LIFT FACILITIES, TRAILS, RUNS AND TERRAIN INVOLVES SUBSTANTIAL AND INHERENT RISKS, HAZARDS AND DANGERS. THESE MAY INDIVIDUALLY OR COLLECTIVELY RESULT IN INJURY, INCAPACITY, PARALYSIS, DEATH OR DAMAGES TO PROPERTY AND MAY ORIGINATE FROM ANY NUMBER OF FACTORS INCLUDING WITHOUT LIMITATION BARE SPOTS, VARIATIONS IN TERRAIN, EXISTING AND CHANGING SNOW CONDITIONS, CHANGING WEATHER CONDITIONS, LIGHTNING, THUNDER STORMS, DIFFICULTY WITH ROUTE FUNDING, HIGH ALTITUDE, LOADING, RIDING AND UNLOADING THE SKI LIFTS, MECHANICAL OR EQUIPMENT FAILURES, ROCKS, STUMPS, TREES, CLIFFS, STREAMS, WILDLIFE, CLOSED AREAS, COLLISIONS WITH OTHER PARTICIPANTS, AVALANCHE AND NON-AVALANCHE RELATED SNOW IMMERSION, COLLISION WITH NATURAL OR MAN-MADE OBJECTS OR FEATURES WHICH MAY NOT BE MARKED OR MAY BE TOTALLY OR PARTIALLY CONCEALED. SNOWMAKING AND GROOMING ACTIVITIES AND EQUIPMENT MAY BE ENCOUNTERED AT ANY TIME. PARTICIPANT AGREES TO FOLLOW ALL AREA RULES AND REGULATIONS THAT MAY BE ISSUED FROM TIME TO TIME BY THE AREA AS WELL AS INSTRUCTIONS RECEIVED FROM AREA STAFF.

6. APPLICABLE PORTIONS OF THE WYOMING STATUTES, AND THE TERMS AND CONDITIONS OF USE ARE POSTED IN VARIOUS LOCATIONS THROUGHOUT THE AREA. PURSUANT TO THE RECREATION SAFETY ACT, FOUND AT W.S. §1-1-121 ET. SEQ., AND SPECIFICALLY W.S. §1-1-123.4(A), THE PARTICIPANT ACCEPTS AND ASSUMES ANY AND ALL RISKS AND DANGERS ASSOCIATED WITH THE AREA AND THE RELATED ACTIVITIES. IF PARTICIPANT LEAVES THE BOUNDARIES OF THE AREA PARTICIPANT ASSUMES ALL RISK AND RELEASES SLEEPING GIANT FROM ANY AND ALL CLAIMS RELATED TO ANY INJURY OR DAMAGE OCCURRING OUTSIDE THE AREA BOUNDARIES WHETHER OR NOT PARTICIPANT UTILIZED ANY OF THE AREA OR FACILITIES TO REACH THE OFF-AREA LOCATION. IF PARTICIPANT DESIRES FINANCIAL PROTECTION AGAINST PERSONAL INJURIES, PARTICIPANT MUST OBTAIN APPROPRIATE INSURANCE, INCLUDING WITHOUT LIMITATION LIFE INSURANCE, HEALTH INSURANCE AND/OR GENERAL LIABILITY INSURANCE WHICH MAY PROVIDE COVERAGE IF PARTICIPANT INJURES ANOTHER PERSON OR THE PROPERTY OF ANOTHER. PARTICIPANT AGREES TO INDEMNIFY AND HOLD SLEEPING GIANT HARMLESS FOR ANY CLAIM OR CAUSE OF ACTION THAT MAY ARISE RELATED TO THE CONDUCT OF THE PARTICIPANT IN USE OF THE AREA FACILITIES. THE PARTICIPANT'S PARENT(S) OR LEGAL GUARDIAN(S) SHALL BE LIABLE FOR ANY DAMAGES OR INJURIES CAUSED BY PARTICIPANT. IN ADDITION, PARTICIPANT FURTHER AGREES THAT JURISDICTION FOR ANY CLAIM OR CAUSE OF ACTION ARISING FROM THE USE OF THE AREA FACILITIES SHALL BE BROUGHT EXCLUSIVELY IN THE DISTRICT COURT OF THE FIFTH JUDICIAL DISTRICT OF THE STATE OF WYOMING, WITH VENUE IN PARK COUNTY.

7. THIS DOCUMENT SHALL BE EXECUTED BY THE PARTICIPANT AND BY THE PARTICIPANT'S PARENT OR LEGAL GUARDIAN IF UNDER THE AGE OF EIGHTEEN PRIOR TO PARTICIPATION IN THE PROGRAM. THE TERMS AND CONDITIONS OF THIS WAIVER AND RELEASE SHALL BE BINDING UPON PARTICIPANT AS WELL AS PARTICIPANT'S PARENT(S) OR LEGAL GUARDIAN(S) IF THE PARTICIPANT IS LESS THAN EIGHTEEN YEARS OF AGE.
